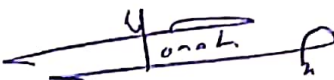

Narayan Zantye College of Commerce: **Post Industrial Estate, Vathadev, Sarvan, Bicholim Goa.**

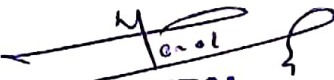
Shri Pandurang D. Raut Higher Secondary School: **Mulgao, Assonora, Goa** represented by Head of the institution of both the educational institutions.

WHEREAS

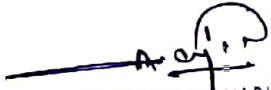
- A. The Parties are interested in working together in connection with the Purpose which is described in this Memorandum.
- B. This Memorandum sets out the initial relationship between the Parties as well as the respective rights and responsibilities of each Party.
- C. Each Party respectively is expected to act in good faith in accordance with this Memorandum.

PROJECT AND PURPOSE

- (a) The Parties intend to actually work together, on a project which will be referred to as students education.
- (b) The purpose of this MoU is to create a supportive and collaborative environment that fosters the holistic development of students.
- (c) The college will provide infrastructure facilities for organizing academic or non-academic programme for Higher Secondary School students and teachers.
- (d) College will conduct workshop, training and organize sessions aiming at overall development of Higher Secondary School students.
- (e) College will conduct workshops, training and organize sessions for professional development of Higher Secondary School teachers.
- (f) The Higher Secondary School will provide infrastructure facilities for organizing academic or non-academic programme for their students

- (h) College will provide resources, mentors, experts etc. for conducting workshops/conferences/ training program's etc.
- (i) College will organise skill oriented short term courses for the Drop-out students of Higher Secondary School.
- (j) College will organise Cultural and Sports activities for the students of Higher Secondary School.
- (k) College will conduct Community development activities in collaboration with the Higher Secondary School to foster the sense of social responsibility among the students.

CHANGES TO MEMORANDUM

- (a) This Memorandum may be amended at any time by written agreement between both the Parties.
- (b) Any changes to this Memorandum must be made in writing and signed by both the Parties.

GENERAL OBLIGATIONS

- (a) The Parties will act in good faith and will use their best endeavours to achieve the Purpose and to give effect to the terms of this Memorandum.
- (b) The Parties hereby acknowledge and agree that they will each respectively perform all acts and execute all documents as reasonably required in order to give effect to the terms of this Memorandum.
- (c) Each Party agrees to cooperate in the spirit of mutual understanding and goodwill in order to develop the Parties' relationships with one another and in order to pursue the Purpose.

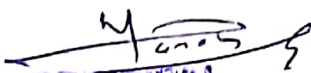
ROLES OF PARTIES

- (a) **First Party** will have the following obligations in relation to the Project:

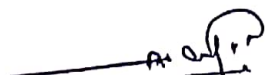
- i) Provide services to the second party as mentioned in this document and vice versa.

The parties will Endeavour to resolve all disputes amicably and with mutual understanding. In case the parties are not able to resolve their differences, the MoU shall be terminated with one week's notice to the other parties.

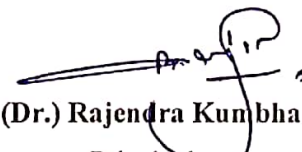

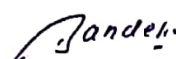
